To give you an idea of costs, it takes approximately 15 minutes (1/4 hour) to search 1 month of emails for one particular keyword. The request is asking for 24 domain name searches and 24 name variation searches from 1/1/18 - 12/2/21, which would be 36 months. The cost for that search alone @ \$120 per hour would be:

(24 domain name search + 24 name variation searches) * 36 months = 1,728 searches which would take 432 hours to complete at a cost of \$51,840.00

Search history for all City computers would involve searching 7 different firewall logs. Those searches we can search 3 months at a time, which again would take 15 minutes per search. (24 domain name search + 24 name variation searches) * 7 firewalls * (36 months/3 months per search) = 84 searches which would take 21 hours to complete at a cost of \$2,250.00

It takes approximately 15 minutes (1/4 hour) to search 1 account for 1 month of e-mail for a particular keyword. The hourly cost would be \$120 per hour.

There are currently 184 City e-mail accounts. The request is for 2 keywords, and 4 outside e-mail addresses (essentially a keyword search as well), so 6 total.

My calculation would be 184 * 6 = 1,104 quarter hours, or 276 total hours per month searched. For 12 months, that would be 3,312 hours of labor. The corresponding charge at \$120 per hour would be \$397,440.
