Chief Burdess,

I requested ALL Iowa Incident Reports from your department months ago, including my name, and I have yet to receive them. I have received correspondence from your lawyer stumbling over a request for, if I remember correctly, several thousand dollars in fees for requested records which I will be dealing with next week. In the meantime, it is my expectation to have the Iowa Incident Report portion of my request printed and ready for me to pick up prior to the close of business today for the Newton, IA Police Department. Chief Tupper of the Marshalltown, IA Police Department had the decency to provide all of his Iowa Incident Reports and my name card listing all incidents regarding myself at no cost. These Iowa Incident reports included all of the documented false allegations and zero evidence the Iowa Conference of the United Methodist Church and Hope United Methodist Church utilized in their attempt to criminalize me after I filed a complaint against this church regarding sexual misconduct in 2018. This is the same situation your officers escorted the Marshalltown, IA Police Department to my door in June 2019. Chief Tupper of the Marshalltown, IA Police Department has my respect because he has shown me he is not a part of that paradigm of injustice that impacted my life. When I requested transparency, he provided it.

I think you would find my patience and forgiveness toward your department would be more forthcoming if you had the decency to meet with me when your presence is requested. If the leadership of the Newton, IA Police department picks and chooses which citizens they talk to and which they ignore when their presence is requested, this could be considered evidence of prejudice. Prejudice is the garden in which discrimination grows. In the current cultural climate regarding how law enforcement is perceived in the national news and on social media, I do not believe this is the perception you want or should be promoting.
