Mr. Brick,

The legal advice you provide your client is of no concern to me. I am not a lawyer. I am a citizen attempting to access public accommodations; the City of Newton, IA has denied me since 2019 based upon what evidence suggests were questionable ethics while you conceal records documenting it. The leadership of Chief Burdess has accomplished nothing in this case but enabling domestic abuse and child concealment across the states of California, Iowa, and Montana. At the same time, my children were concealed from the court having jurisdiction nearly 2000 miles away by conspirators utilizing false allegations of sexual abuse while living with an Iowa State University Education Director that coordinates educational events for other Iowa parents' children.

Suppose the legal advice you provide the City of Newton, IA, damages my ability to receive adequate law enforcement services I have been denied since 2019 before the end of the statute of limitations on a restraining order your client disregarded in August 2019. In that case, Brick Gentry, P.C. will share the weight of the damage I carry on my shoulders every day with the City of Newton, IA.

In my analysis of this situation, the City of Newton, IA, and Brick Gentry P.C., based upon the historical record of what I have witnessed from both organizations, are nothing more than a straw house avoiding a solid ethical wind. I did not serve this country for twenty years to have my parental rights compromised by an unethical and incompetent badge or a suit that cannot properly execute their responsibilities, or properly execute a record concealment strategy while accomplishing nothing more than wasting my time. I did not serve this country for twenty years to come home to a republic where the wounded and the innocent are destroyed by corrupt politicians, badges, suits, or the criminal element while possessing a false sense of entitlement that I helped enable by providing them sovereign ground to focus only on the elevation of their status and political power. Yet, at the same time, as the evidence indicates, these parties investigate and spread false testimony against the innocent while attempting to charge them with a crime while trying to prevent them from exposing proof of their negligence and possible violations of the laws.

I provided Chief Burdess a signed legal document on 08 JUN 2022 notarized in the state of California under oath in accordance with California Penal Code 118a produced by Claudia J. Bergman in the presence of a licensed California notary acknowledging she violated my domestic abuse protection order. I did his job investigating and acquiring that document across three states because Chief Burdess and the Newton, IA Police Department have consistently produced evidence indicating a bias against male victims of domestic abuse and harassment. It does not matter to me if you both sit in folding chairs and hold hands. At the same time, I give my testimony and reference the sections of the Iowa Code that indicate this case is still within the limitations of our laws in accordance with Iowa Code Section 802.3. Suppose the City of Newton, IA fails to properly handle this situation. In that case, we will have much more to talk about after the exhaustion of the statute of limitation for criminal acts Chief Burdess and his officers have completely ignored since 2019.

As of today, there are two California Superior Court Judges that are unethically impacting the lives of children and their right to equal access to their parents in accordance with the California Family Code and basic human rights that are protected by the Constitution of the United States of America. There is an Iowa State University Education Director that coordinates educational events for the children of Iowa while evidence shows she violated two children's rights as protected by Iowa Code Section 598.1 while concealing them from court-ordered appearances they were ordered to provide their testimony regarding allegations of sexual abuse these conspirators utilized. The leader of this conspiracy is now a social worker in Montana. We live in a capitalistic society where the entitled feel that if

they wrap their wounds with cash acquired in civil court it will ease their pain and suffering. The only thing that will ease my pain and suffering is using the skills I have acquired over my career to provide evidence so the people can determine whether these judges, lawyers, law enforcement officers, and citizens should continue in their current professions while producing a healthier paradigm for the parent child relationship within this republic. You have expressed that the City of Newton, IA is owed a form of financial compensation for the records I have requested. I am in the position to provide the City of Newton, IA nothing. The City of Newton, IA can either provide the records I have requested it is required to release in accordance with the laws of our state while respecting and protecting my rights as a citizen of this municipality, or if you prefer we can ascertain in court which party is owed money in this case. It doesn't matter to me, either way, my expectation is that you clear my path and provide the records I have requested so that I can continue the work I am doing to protect the rights of children and other parents that were taken from me while you have sat at your desk and improved the thread count on the suit you are wearing at this moment.

Chief Burdess:

I was in the Newton, IA City Hall this morning regarding the following issues:

-Evidence of abuse of power regarding the professionalism, communications, and manner in which your parking ticket officer spoke to Monica L. Speaks and myself on 720 1st St S, Newton, IA 50208 before aggressively speeding off in her City of Newton, IA truck in a manner that appeared to violate municipal code and posted speed limits. (I will be requesting the GPS data of her vehicle to provide evidence of how she drove off after verbally abusing Monica L. Speaks and myself while improperly using her position and authority.

-Questions regarding why you have failed to take action regarding evidence I have provided you in the form of a signed, notarized document showing my restraining order was violated by the individual I reported to you in August 2019. Iowa Code stipulates the domestic abuse I have reported to you that produced the psychological trauma I have endured is a serious injury. Other portions of the Iowa Code would indicate that the specifics of my restraining order are still within the 3-year limits of law regarding this misdemeanor because it involves a psychological injury documented in my medical record. Your subordinate Officer Camp arrived at my address to ensure I was being taken to the Des Moines VA Hospital in Spring 2019 because I didn't want to live anymore because of the damage caused by this multi-year abuse, correct? Therefore, evidence indicates the conclusions you and the County Attorney have formulated regarding this case are wrong are clearly documented in the Iowa Code that protects a citizen's right to protection from domestic abuse while having an out-of-state restraining order which I provided you.

The law enforcement evidence in this municipality clearly shows gender-based discrimination regarding how you execute your job and lead your personnel. The City of Newton, IA will be receiving additional legal paperwork from me in the upcoming weeks regarding what I believe the evidence shows is a failure to provide public accommodations while possibly executing gender-based discrimination regarding LT Cook's alleged availability while a female was with me, and when she had to depart LT Cook failed to appear as requested in the main lobby to render public accommodations regarding his duty to the citizens he serves. This is reinforced by months' worth of electronic mail from me asking to speak with you in person you have failed to accommodate. At the same time, LT Cook's email in a previous public records release boldly claims you both have no intention of speaking to me. At the same time, your published Facebook video boasts your joy of interacting with the citizens you serve. Why am I being denied this publicly communicated public outreach accommodation regarding speaking with the local Chief of Police.

I would also like to communicate the level of contempt, and emotional-based rhetoric that was apparent against Monica L. Speaks and myself by your Parking Ticket Officer is irrelevant and highly dangerous for a person who has been put in the position of law enforcement. Suppose she continues to angrily persecute

citizens while personifying the darkness within humanity in a law enforcement uniform while citizens are trying to talk to her and communicate with her. In that case, the only question that remains is whose neck will her knee be on in the future when she is issued a weapon from a law enforcement department that has demonstrated nothing other than prejudice, discrimination, and cover-up. Another relevant question is whether your officer's attitude toward Monica L. Speaks, and I is simply a covert manifestation of how your department feels about me after filing a complaint against you with the Iowa Public Information Board as documented in your public records you have released and those you have chosen to conceal. At the same time, its leadership hides behind their desks whenever I have asked to talk to you for at least a year, possibly longer.

If that analogy offends you, I have accomplished my objective because it is a point that needs to be made. You all stood with protestors in "solidarity" after George Floyd was murdered by a law enforcement officer the night that allegedly there were to be numerous parties from out of town moving through our city limits to start a riot. Chief Burdess, the evidence I have witnessed while living here, I believe, forms a solid thesis that the only thing you stand in solidarity with is the tree that provides darkness to cover your ass.
