**Re: Response to Records Requests**

Dear Mr. Merritt:

The City is in receipt of your August 16<sup>th</sup> open records request. Your latest correspondence appears to include two requests for information:

1. To provide supervised access to the City's mail servers for you to view "the list of citizen electronic mail addresses" that the City "has currently blocked from publishing electronic mail to their municipal mail servers;" and
2. A copy of the above-referenced list.

Pursuant to Iowa Code 22.2, your right is to examine and copy a public record not to be provided access to City data processing systems—including, but not limited to, the City's email servers. As such, your first request is denied. In accordance with Code Section 22.2.2, and in lieu of in-person examination, the City is providing at no cost the attached copy of the email addresses that are currently blocked by the City.


Finally, City staff has been included in a number of emails and letters from you to government officials asking questions and seeking information. If there is additional information you are specifically requesting from the City, let me know and I will provide an updated response. If you have any questions or comments about this response, please let me know.
