1. Iowa Open Records Request

The following records are being requested in accordance with Iowa Code Chapter 22.

- 1. The City of Marshalltown, IA's, billing receipts with BDH Technology for August 2022 and January 2024. The City of Marshalltown, IA's public MX domain name system (DNS) records show the City of Marshalltown, IA, has contracted with BDH Technology which maintains locations in the City of Marshalltown, IA, and Cedar Rapids, IA.
- 2. The City of Marshalltown, IA's, billing receipts for all software licensed from "Zimbra" or "Synacor, Inc." the makers of the Zimbra email, collaboration, and productivity tool. Electronic Mail header data provided by the City of Marshalltown, IA confirms that the City of Marshalltown, IA, has utilized Zimbra from (known) Wed, 07 Apr 2021

06:42:09 -0500 (Zimbra 8.8.15_GA_4018 (ZimbraWebClient - GC89 (Win)/8.8.15_GA_4007)) through Mon, 08 Jul 2024 16:01:27 -0500 (Zimbra 9.0.0 GA 4612).

- 3. Any contractual agreements, receipts, invoices, or correspondence confirming amounts shown in the City of Marshalltown, IA's, <u>Chief of Police Michael Tupper's 16 AUG 2022 signed and notarized affidavit</u> provided to the Iowa Public Information Board in August 2022.
- 4. Any contractual agreements, receipts, invoices, or correspondence confirming the amount shown in the City of Marshalltown, IA's, <u>City Clerk Alicia Hunter's 18 JAN 2024 signed memorandum</u> provided in response to The Form of the Constitutional Maverick Iowa Open Records Request Iowa Municipal Government Bodies Consolidated CM-X2 Elimination of the Fog of War Section 04 of 05 16 JAN 2024.
- 5. Any contractual agreements, terms of service, terms of use, or any other legal documents between the City of Marshalltown, IA, and Cybersecurity & Infrastructure Security Agency or Cybersecurity & Infrastructure Security Agency Region 7 that articulates the rules and requirements for the use of .gov domains.
- 6. The City of Marshalltown, IA's billing receipts with the organization that provided the City of Marshalltown, IA's full-duplex TCP/IP connection to the global internet (ISP/internet service provider) for the months of August 2022 and January 2024.
- 7. Any other contractual agreements the City of Marshalltown, IA, has with Cybersecurity & Infrastructure Security Agency, Cybersecurity & Infrastructure Security Agency Region 7, BDH Technology, Zimbra, Synacor, Inc., or any other public or private organization that provides on-premises or off-site information systems, telecommunications services, or software licenses.
- 8. The City of Marshalltown, IA organization chart listing job function and tasking of all City of Marshalltown, IA taxfunded employees, contractors, interns, police dogs, police bobcats, or lost cardinals.

The lowa Attorney General's Office advises that most requests for records are routine and should be handled immediately. Chapter 22.8(4) allows for a "good-faith, reasonable delay" under certain circumstances, including determining whether the records are confidential and not available to the public. The official having custody of the records being sought is allowed up to 20 calendar days to determine whether the documents should be released, but such delays should not ordinarily exceed 10 business days.

The lowa Supreme Court ruled in a 2013 case (*Horsfield Materials Inc. v. City of Dyersville*) that a government agency can have additional time to comply with a public records request when "the size or nature of the request makes prompt access infeasible."

If there is a copying fee, please inform me in advance if it is more than \$0. Iowa Code Chapter 22.3 states that the fee shall not exceed the actual cost of providing the service.

2. Analysis of Available Data

1. The City of Marshalltown, IA City Clerk Alicia Hunter communicated the following response in her <u>18 JAN 2024</u> memorandum,

"RESPONSE (b. - g.): The actual cost of responding to this request would require a search to be conducted by the City of Marshalltown IT-contractor. It takes approximately 15 minutes to search 1 account for 1 month of email for a particular keyword. The hourly cost would be \$120 per hour. The City currently has 184 email accounts. The request is for 2 keywords and 4 outside email addresses. The estimate would be 184 accounts \times 6 keywords =

- 1,104 quarter hours or 276 total hours per month searched. For 12 months, that would be 3,312 hours of labor at \$120 per hour, totaling \$397,440.00. Furthermore, all non-routine such as this require attorney review for legally protected confidential information which would have costs at \$200 per hour. Payment for this search would be required in advance."
- 2. The City of Marshalltown, IA Clerk Alicia Hunter confirmed in her <u>18 JAN 2024 memorandum</u> that the city has "184 email accounts" on its municipal network.
- 3. The City of Marshalltown, IA City Clerk (18 JAN 2024) and Chief of Police (16 AUG 2022) utilize a multiplier indicating that electronic mail searches must be performed independently for each City of Marshalltown, IA employee/authorized user account. This paradigm is not unique to the City of Marshalltown, IA. The City of Newton, IA, which evidence shows has also been involved in unethical conduct against the originator of this public records request, has also deployed a similar multiplier while reporting fees that evidence indicates are not consistent with lowa Code Section 22.3.
- 4. The City of Marshalltown, IA's electronic mail header, viewable by any citizen in receipt of electronic mail from the City of Marshalltown, IA, reveals that the City of Marshalltown, IA, municipal employees access electronic mail via the <u>Zimbra Web Client</u>. This provides evidence that no electronic mail is stored on local end-user computers, and all data is centrally stored on a server that is accessed via the <u>Zimbra Web Client</u> (Note: The version of the web client utilized is relative to the historical point in time the electronic mail was sent and what version of Zimbra the City of Marshalltown, IA was currently utilizing). This conclusion, supported by the evidence, establishes that only a search of one location (information systems server) is required to complete any lowa citizen's request for electronic mail records with the City of Marshalltown, IA.
- 5. The City of Marshalltown, IA electronic mail header within <u>Clty Clerk Alicia Hunter's 18 JAN 2024</u> response reveals that the City of Marshalltown, IA was at the time of the <u>City Clerk's 18 JAN 2024 memorandum</u> utilizing Zimbra 9.0.0 GA 4583 (<u>ZimbraWebClient</u> GC120 (Win)/9.0.0 GA 4583)
- 6. Reference (2.) below articulates the following within the <u>Zimbra 9.0 Collaboration Administrator Guide</u> Section: Manage Cross Mailbox Search,

"This role creates a delegated administrator role that <u>can run the Search Mail tool to search mail archives or</u>
<u>live mail for accounts.</u> This also allows the administrator to create, abort, delete, purge or get status of a <u>cross</u>
<u>mailbox search request."</u>

7. Reference (3.) below articulates the following within the <u>Zimbra 9.0 Collaboration Administrator Guide</u> - Section: <u>Searching Across Mailboxes</u>,

"When the archiving and discovery feature is installed, you can search across mailboxes either from the Administration Console or through the command line interface.

You do not need to have any archive mailboxes configured to search across mailboxes, but the Archive package must be installed."

3. Conclusion

City of Marshalltown, IA Police Department: "This is Car 4, we're in pursuit of the '77 Pyrebird. It's the Cipher Hunter."

OG: "So how do you think the City of Marshalltown, IA, is going to respond Merritt?

Cipher Hunter: "Well, if I were to guess, and keep in mind it's 3 in the morning and I haven't had my morning Pepsi yet. But if I were to provide a reasonable level of speculation based upon historical evidence showing some within the State of lowa's elected and appointed elite's behavior that evidence indicates lacks any form of ownership that the average citizen is expected to manifest, I would say I will probably receive an email sometime next week communicating that the City of Marshalltown, IA did not have or know about the Zimbra Archive package that is properly articulated in the Zimbra 9.0 Administrator Guide and that it is now installed on their server and they are now able to complete the requested search thanks to PFM. Because in this case I believe the evidence indicates it is better for the City of Marshalltown, IA to publicly acknowledge complete incompetence as opposed to acknowledging or reinforcing evidence that may reveal a possible violation of lowa Code Section 714.8(3.)/714.8(4) as determined by the lowa Court."

The Form of the December 2024 City of Marshalltown, IA Police Department's Second Search of the Cipher Hunter's Modest Chateau

Cipher Hunter: "Hold it right there!"

The City of Marshalltown, IA Police Department Chief Tupper: "This is the Marshalltown, IA Police Department, Mr. Merritt."

Cipher Hunter: "I knew it was you. I could smell JBS swiftly moving through the crack in the door. You was here in June 2019 with zero evidence supporting a crime too wasn't you?"

The City of Marshalltown, IA Chief of Police Tupper: "Yes, Mr. Merritt, we were."

Cipher Hunter: "You was here, and you were smooching with my brother."

The City of Marshalltown, IA Chief of Police Tupper: "I'm afraid you are mistaken, Mr. Merritt."

Cipher Hunter: "Don't give me that. You've been smooching with everybody Snuffy, Al, Leo, Little Mo with the gimpy leg, Cheeks, Boney Bob, Rob."

The City of Newton, IA Chief of Police Burdess: (Gasp) "No..., It's a lie."

Cipher Hunter: "I could go on forever, baby."

The City of Marshalltown, IA Chief of Police Tupper: "I'm terribly sorry, Mr. Merritt, but I'm afraid you are mistaken. We're looking for a Veteran with service-connected mental health disabilities..."

Cipher Hunter: "Alright, I believe you, but my book of jokes I wrote at sea don't. Get down on your knees and tell me you love me."

The City of Marshalltown, IA Chief of Police Tupper: "on our knees..., I love you, Mr. Merritt."

Cipher Hunter: "You got to do better than that."

Chief of Police Tupper and Chief of Police Burdess: "We love you, Mr. Merritt."

Cipher Hunter: "Maybe I'm off my hinges, but I believe you; that's why I'm going to let you go. I'm going to give you all to the count of three to get what evidence indicates is your lousy, lying, public record concealing, false allegations of criminal conduct, low down, four flushing carcasses out my door before I start telling jokes. 1...2..."

The City of Marshalltown, IA Chief of Police Tupper: "Open the door! Open the door!"

Cipher Hunter: "Why did the lowa Republican go to an LGBTQ parade? Because they are bipartisan. HA HA HA HA. Why did the lowa Farmer stop planting corn and use his field for wind turbines? Because he wanted to make a living from only fans. HA HA HA HA HA HA. Where does the City of Marshalltown, IA, store and preserve public records that it doesn't want to release? In Tupperware. HA HA HA HA HA. Why did the MAGA Star Wars fan tape his Jabba the Hutt toy to a cross? Because he wanted a Trump Crucifix next to his Trump Bible. HA HA HA HA HA HA. Where is the best place for a comedian with no talent to get his first gig? At a City of Marshalltown, IA City Council Meeting. HA HA HA HA HA. 3. Merry Christmas, you public records concealers."

Legal Disclaimer: In this correspondence, the use of the word "smooching" is defined as evidence supporting an inappropriate inter-law enforcement departmental relationship that produced evidence of unlawfully targeting a specific citizen. At the same time, neither law enforcement department had any evidence that the targeted citizen had manifested any acts or evidence supporting a criminal violation of our laws, as articulated in Iowa Code Chapters 687 - 916. In this case, as supported by electronic mail correspondence and other related police reports released in accordance with Iowa Code Section 22.7(5.) that were requested in accordance with Iowa Code Section 22.4(2.), the originator of this public records request has evidence in his case file supporting that the Marshalltown, IA Police Department and the Newton, IA Police Department Chiefs of Police were "smooching" from approximately (known) 06 JUN 2019 - 16 JAN 2020.

Why would the City of Marshalltown, IA, charge almost \$400,000 for a public records search that Iowa State University (approximately 30,000 users based on publicly available information), University of Iowa (approximately 30,000 users based on publicly available information), and University of Northern Iowa (Approximately 11,000 users based on publicly available information) were all able to complete for \$60 (Iowa State University) or for \$0?

If I were to communicate logical speculation as supported by the evidence it would seem reasonable that the City of Marshalltown, IA does not want the people of lowa to know who else the City of Marshalltown, IA Chief of Police Tupper has been "smooching" with.

Note: It would seem the City of Newton, IA, has changed mail providers (I provided the leadership of the State of lowa evidence a few months ago of a public-facing mail portal at mail.newtongov.org that indicated an implementation of Microsoft Exchange Server 2019. At the same time, Microsoft Exchange Server 2019's OST/PST mail storage implementation does not store email in the same manner that City of Newton, IA Attorney Brick articulated when he requested several thousand dollars to search the City of Newton, IA's mail records. I wonder if they are also now able to perform electronic mail searches without having to search each individual mail account.

City of Newton, IA: Are you all going to lock down your electronic mail web access portal with a security certificate, or are you just going to keep broadcasting usernames and passwords in the clear across the global internet? If this site is currently being utilized, it is my recommendation that your system administrator force a password reset on all user accounts. It must be assumed that all passwords are compromised if users have been logging into a site that is not properly encrypted.

Good evening, Sir; I am sending this correspondence to communicate my intention to stop by your office next Tuesday to talk to you at your convenience or to schedule an appointment. I want to introduce myself and convey my appreciation and gratitude toward the evidence I have tracked over the last several years that indicates your office, on more than one occasion, protected my rights and liberties as supported by the evidence from the alleged malicious, unethical, and possibly unlawful conduct among the unethical within your peers, law enforcement partners, and a few select citizens of the State of Iowa.

I was born and raised in Marshalltown, IA. I graduated from Marshalltown High School in the class of '97. I will be reaching out to the Secretaries of the United States and Iowa Departments of Veterans Affairs and communicating my request for a delay in the determination of my service connection for post-traumatic stress disorder (PTSD) and military sexual trauma (MST) until further notice to provide time for me to organize all of the evidence that I have and request additional records from the State of California and the United States Navy. The United States Department of Veterans Affairs elevated my disability as it relates specifically to my mental health disabilities from 50% (2017) to 70% (2023) in a letter dated 01 MAY 2024. I believe that this data, in conjunction with the evidence in my mental health records and public records that I have collected (as well as evidence supporting involved lowa government bodies that evidence shows have refused to provide public records in accordance with lowa Code Chapter 22), provides a reasonable conclusion that the evidence showing the unethical and malicious behavior manifested by the lowa Department of Public Safety, some IDPS law enforcement partners, Jasper County, IA Attorney Scott Nicholson, and <u>lowa Public Information Board</u> Executive Director Erika Eckley is not in line with our constitutional values and laws that led to my publicly documented service-connected mental health crisis that occurred during 2023 (documented by the Iowa Press in September 2023 and my United States Department of Veterans Affairs Mental Health Records) and the further decline of my health that has been ongoing since returning to the State of Iowa after retiring from the United States Navy in 2017.

After I complete my move into my Marshalltown, IA, apartment, I will be reaching out to <u>lowa Department of Public Safety Commissioner Stephan Bayens</u> and the following lowa Government Bodies to request legal counsel points of contact and public records regarding the evidence of their unethical conduct to serve court documents and subpoenas to lowa government body employees who will testify in the lowa Court regarding the evidence of their unethical and possibly unlawful conduct. I intend to subpoena <u>lowa Department of Public Safety Commissioner Stephan Bayens</u> and his entire executive leadership team so that the people of the State of lowa can fully understand why his department has produced so much evidence of disregarding or failing to respond to a public records request that requested information related to what the lowa Press documented in September 2023 and public records released by the lowa Public Information Board indicates the lowa Department of Public Safety was involved in correspondence with the lowa Public Information Board coordinating an attempt to criminalize service-connected mental health disabilities and an attempt to unlawfully restrict access to rights, liberties, and public accommodations that were orchestrated by <u>lowa Public Information Board Executive Director Erika Eckley</u> as supported by the evidence.

My reason for getting my own apartment is that I have difficulty functioning in environments with others because of the trauma I have experienced for the last several years while living in the State of Iowa, as

supported by the evidence. I intend to isolate myself in a studio apartment while I develop a healthy habitual life process close to the Marshalltown VA Medical Center. At the same time, I investigate and file court documents against lowa government bodies that have produced evidence that the careers of those who administer these agencies have more value than the lives of those that evidence shows request public records possibly documenting how these government bodies unethical and possibly unlawful acts have impacted the lives and health of those they claim to serve. It is my passion to serve Jesus Christ and dismantle the evil I have experienced to protect others, which helps me get through public meetings.

I wear the simple clothes that have been ridiculed by the State of Iowa as "pajamas," as documented by the Iowa Press, because they are all I have, as I have invested everything I have in this work. At the same time, my spirituality motivates and inspires me to dress humbly before God. Nearly every day of my life, I feel very sick from anxiety-based digestive issues that have only worsened while dealing with the evidence of the unethical and abusive behavior that is manifested by the leadership of the State of Iowa. Before I moved to the City of Newton, IA, I used to go to Planet Fitness in Marshalltown, IA, every day and was very health-focused. I intend to return to that in an environment where I can better focus on my healthcare through the Department of Veterans Affairs. At the same time, I perform damage control on the starship, which is my personal health.

I will not seek this world's silver coins related to the pain and damage I carry within my soul that manifested from the evidence of these events within the State of Iowa since I retired. I will be producing a template of leadership, honor, courage, and commitment that I will continue to manifest until I have lawfully and ethically dismantled the evil within the State of Iowa's law enforcement and leadership that has destroyed my family and my life. There is no way that I can communicate the multi-dimensional paralyzing pain within this correspondence that I feel during every moment of my life within my soul. All I know is that I am going to fix the evidence of this State of Iowa government body misconduct and unethical behavior that evidence shows occurs within the State of Iowa in accordance with my faith in Jesus Christ and our laws. I believe it is necessary for the honorable within the State of Iowa to step up and produce change that will protect the rights and liberties of others because I believe the evidence indicates the Iowa Legislature has its head lodged so far up its entitled and unethical MAGA ass that many of its elected members are unable to see the form of bigotry, incompetence, and constitutional bankruptcy they manifest. At the same time, many of the State of Iowa's leaders endorse a convicted criminal for President of the United States of America that is currently drowning in the evidence of his own lifelong misconduct and the evidence supporting his historical abusive behavior toward other citizens (specifically women).



"We've had some issues with individuals filing hundreds of requests and engaging in abuse – what many would consider abusive and harassing conduct related to those," Eckley told the committee. "And so looking at it there's not a lot that individuals can do if they're in that situation. There's very little that they can do other than to continue to just take the harassment and continue to have to review the information from that individual to make sure they are complying with their (Open Records Law) requirements."

"She added that she has "become aware of an individual basically automating across all counties, all school boards, all cities, and such, seeking extensive records and then the communications after that can be quite abusive and harassing."

3. Request Guidance

- (a.) The originator requests to be informed of any estimated fees in accordance with Iowa Code Section 22.3 before performing the requested search.
- (b.) The desired format of requested data: Thumb drive (at the government body published rate) or electronically submitted portable document formatted (PDF) files.
- (c.) Distribution of Requested Records: Priority United States Postal Service (USPS) mail or electronic mail sent to the originator of this request.

4. The Form of the Iowa Public Information Board

The form of the lowa Public Information Board is displayed by the evidence that shows that upon receipt of evidence showing lowa government body behavior against an lowa public records requester consistent with the requirements of Iowa Code Section 708.7(1.)(a.)(4.) the Iowa Public Information Board did nothing to protect the rights of citizens. On the contrary, the Iowa Public Information Board utilized tax dollars to produce a proposed addition to Iowa Code Chapter 23, allowing it to terminate citizens' rights to request public records "for a specified period of time, but not to exceed one year," (See: Reference (14.) Proposed Iowa Code Section 23.8A(f.) At the same time, the Iowa Public Information Board spread a false criminal allegation supported by zero evidence against that public records requester (See: Enclosures (4.), (5.) and (6.) to fuel and justify this proposed legislation while protecting government bodies from accountability regarding evidence of their abuse of power and hostility toward an Iowa public records requester regarding requested public records evidence indicates these government bodies desired not to release (Note: Section 9 of Article 1 of the Constitution of the State of Iowa states: "Right of trial by jury—due process of law. The right of trial by jury shall remain inviolate; but the general assembly may authorize trial by a jury of a less number than twelve men in inferior courts; but no person shall be deprived of life, liberty, or property, without due process of law.")

Ultimately, this behavior manifested by the Iowa Public Information Board is the responsibility of Iowa Governor Kim Reynolds and the Iowa Legislature as articulated in Iowa Code Sections 23.3(1.).

"An Iowa public information board is created consisting of nine members appointed by the governor, subject to confirmation by the senate. No more than three members appointed shall be representatives from the media including newspapers and no more than three members appointed shall be representatives of cities, counties, and other political subdivisions of the state."

Iowa Code Title I State Sovereignty and Management, Chapter 23 Public Access to Government Information (Iowa Public Information Board Act) - Section 23.3(1.) - Board appointed —executive director.

Evidence showing that Iowa Public Information Board Executive Director Erika Eckley's actions, selection, and continued appointment are the responsibility of the Iowa Public Information Board is shown in Iowa Code Section 23.3(6.).

"The board shall select one of its members to serve as chairperson and shall employ a person who shall be an attorney admitted to practice law before the courts of this state to serve as the executive director of the

board."

Iowa Code Title I State Sovereignty and Management, Chapter 23 Public Access to Government
Information (Iowa Public Information Board Act) - Section 23.3(6.) - Board appointed —executive director.

Ultimately, as evidence indicates, this behavior is to be expected in a state whose governor has faced civil court action regarding failure to provide public records and an attorney general who has endorsed a candidate for President of the United States of America who is currently involved in multiple criminal and civil court cases across various states (**See:** Enclosure (2.) and (10.).

Tyranny and corruption will reign in a state whose leadership manifests evidence of or endorses lawlessness. At the same time, under this form of leadership, citizens will be abandoned in a fog of deceit, with every concealed public record and every banned book.
